I. GENERAL PROVISIONS

The general regulations for port and quay tariffs and the general terms and conditions of Fährhafen Sassnitz GmbH (AGB) have to be noticed when using the services of Fährhafen Sassnitz GmbH.

II. SECURITY FEES / ISPS ACCESS FEES

The security fees / ISPS access fees for tenants/leaseholders/authorized heirs within the ISPS area (the port users) is levied as follows for the respective rented/leased terminal and/or commercial areas:

ISPS fee for port users:

< 5,000 m ²	0.34 € / m ² / month
5,000 – 20,000 m ²	0.29 € / m ² / month
20,000 – 50,000 m ²	0.23 € / m ² / month
> 50,000 m ²	0.17 € / m ² / month

ISPS fee for port users whose are located in ISPS area that are subject to special access restrictions:

< 5,000 m ²	0.68 € / m ² / month
5,000 – 20,000 m ²	0.57 € / m ² / month
20,000 – 50,000 m ²	0.45 € / m ² / month
> 50,000 m ²	0.35 € / m ² / month

Security fee / ISPS fee for access identity cards:

For the issue of access identity cards with photo or company access cards without photo for the ISPS port grounds following fees must be paid:

- a) for port resident companies and supplier

<i>per card and year, first issue</i>	58.94 €
<i>per card and year, extention</i>	44.59 €

- b) for projects (temporary access):

<i>per card and week, first issue</i>	52.79 €
<i>per card and week, extention</i>	50.23 €
<i>per card and month, first issue</i>	87.12 €
<i>per card and month, extention</i>	72.78 €
<i>per card and year, first issue</i>	249.08 €
<i>per card and month, extention</i>	234.73 €

- c) for crew members:

<i>per card and max. 6 month, first issue</i>	28.70 €
<i>per card and max. 6 month, extention</i>	16.00 €

- d) Loss of ISPS-cards:

<i>fee for lost ISPS-card, per card</i>	73.29 €

The ISPS gate fee is charged for all incoming or outgoing means of transport and passengers in sea traffic per entry or exit to the port facilities.

The Gate Charge, incl. handling fee, amounts for each means of transport as follows:

<i>Truck – tank and liquid bulk</i>	86.10 €
<i>Truck – dangerous goods</i>	151.70 €
<i>Truck - disposal</i>	95.84 €

III. STORAGE -/ STALL FEES; INFRASTRUCTURE FEES

A fee is charged for the provision of covered and open storage areas, stall areas for vehicles, the use of the port infrastructure for bulk cargo, general cargo and container as well the use of the port infrastructure by vehicles of all kinds.

a) The storage fees per calendar day amount to the following:

for bulk goods, general cargo and container, per metric ton or TEU

	<i>uncovered storage area</i>
<i>bulk cargo</i>	0.05 €

<i>dangerous goods</i>	upon request

	<i>covered storage area</i>

b) The stall fees amount to the following:

for each vehicle during the process of import and export

<i>vehicles < 6 m 3 calendar days free, thereafter</i>	<i>18.00 € / day</i>
<i>vehicles > 6 m 3 calendar days free, thereafter</i>	<i>28.70 € / day</i>
<i>vehicles on hazardous goods space</i>	<i>43.87 € / day</i>

c) The infrastructure fees amount to the following:

for driving on and using the port infrastructure (e.g. roads, terminal and pre-storage areas or quay facilities) with vehicles of all kinds is per metric ton or TEU/vehicle/trip:

<i>bulk cargo, general cargo</i>	<i>0,12 € / t</i>
<i>container</i>	<i>2,56 € / TEU / trip</i>
<i>Vehicles from 7.5 tons, incl. trailer, with 2 axles and more</i>	<i>4,31 € / vehicle / trip</i>

d) The fees for rental space amount to the following:

for monthly rent of space for bulk cargo, general cargo and container per m²:

IV. FERRY BRIDGE FEES

For lifting and lowering ferry bridges/ro-ro ramps outside the contractual provisions, a fee must be paid in each case.

Ferry bridge fees amount to the following:

V. FEES FOR CARGO HANDLING SERVICES

For loading and unloading wheeled cargo units a fee must be paid.

Fees for wheeled cargo units amount to the following:

- a) Moving from/on board the vessel by port staff starting at the apron (vehicle is in running condition and can be steered):

<i>truck / bus / tractor</i>	<i>19.99 € / unit</i>

- b) Towing from/on board the vessel starting at the apron:

VI. PORT SERVICES

For port services with mobile port technology and devices from Fährhafen Sassnitz GmbH within the regular working day shift (Monday to Friday from 7 a.m. to 7 p.m. and Saturday from 7 a.m. to 1 p.m.), the calculation is based on the following cost rates:

Unimog truck w/ crane jib 4to incl. operator	162.00 € / h
Terminal truck incl. operator	187.50 € / h
Forklift incl. operator	141.00 € / h
Sweeper truck incl. operator	103.50 € / h
Pick-up truck incl. operator	103.50 € / h

additional workforce	55.86 € / h

For port services which are provided outside of the regular working day shift, the following surcharges apply to drivers and port employees:

Mondays to Fridays 7:00 p.m. – 10:00 p.m.	5 %
Mondays to Fridays 10:00 p.m. – 7:00 a.m.	25 %
Sundays and days before holidays, if these are a workday 1:00 p.m. – 12 midnight	25 %
Sundays, all day	100 %
on days before holidays, if these do not fall on a workday 1:00 p.m. – 12 midnight	100 %
on legal holidays or high feast days, all day	125 %

If requested and/or ordered port services cannot be provided through no fault of Fährhafen Sassnitz GmbH, or if the port user/customer has downtime or waiting times without cancelling in good time, Fährhafen Sassnitz GmbH is entitled to invoice the additional costs incurred by the port user/customer. The time to be charged is rounded up to half an hour. As a minimum amount, the cost rates for half an hour (0.5 h) will be charged.

VII. RENTAL EQUIPMENT

The following fees are payable for the rental and use of equipment and mobile port machinery:

Yokohama fenders 3 x 1.5m	on request
mobile E-lightmasts	12.81 € / day
compact station	on request
mobile power supply box	on request
Extension power cable	on request
Marine gangway	on request
mobile ventilation and heating devices	on request
office container	from 50.23 € / day
storage container	from 27.68 € / day

The minimum charge rate is one day (24h).

VIII. FEES FOR ELECTRICITY

For the consumption of electricity a fee for electricity has to be paid based on the consumption.

The fee for electricity per kWh including network use charges and fees amounts to the following:

up to 32 Ampere (without power measurement)	0.57 €
from 63 up to 125 Ampere (without power measurement)	0.58 €
more than 125 Ampere (with power measurement)	upon request
fee for setting up an electric connection up to 63 Ampere	72.26 € / per connection

IX. FEES FOR WATER AND CONNECTIONS

The following must be paid for drawing drinking water directly on the wharf facilities:

The fee for water amounts to the following:

up to 20 m ³	4.10 € / m ³
21 - 100 m ³	3.75 € / m ³
more than 100 m ³	3.33 € / m ³

The fee for a water supply connection amounts to the following:

up to 20 m ³	15.68 €
more than 20 m ³	40.28 €

X. FEES FOR LOSS OF CARGO HANDLING

If the handling of goods is performed via

- port and quay facilities of Fährhafen Sassnitz GmbH on the part of the ship with on-board handling equipment and own staff (self-loader / self-discharger),
- port and quay facilities of Fährhafen Sassnitz GmbH using its own shore-side handling equipment and its own staff,
- within the port boundaries from ship to ship,
- as transshipment goods (transshipment goods are goods that are delivered to a terminal, but not shipped from this terminal, but only shipped seaward from another terminal after a transshipment/relocation or taken over outboard for seaward shipment) via areas and rail facilities of Fährhafen Sassnitz GmbH on the part of the customer with its own handling equipment and staff,
- as goods transported by rail via areas and rail facilities of Fährhafen Sassnitz GmbH by the customer with his own handling equipment and staff,

charges for lost handling services will be charged as follows:

XI. FINAL CLEANING

12 hours after the end of the transshipment activities at the latest the berths and wharfages shall be handed over tidy and clean (see also Terms and Conditions Fährhafen Sassnitz GmbH item III §4 section 5). The, for the final cleaning, respective client has to be announced in the Notice of Arrival (**Annex 2**). Furthermore shall it be noted in the Notice of Departure (**Annex 3**) that the final cleaning is finished or commissioned. If the client does not fulfil its obligations the Fährhafen Sassnitz GmbH shall raise a fee up to 6,000.00 €, depending on type and degree of contamination.

XII. FEES FOR USING THE RAIL INFRASTRUCTURE

The railroad companies must pay appropriate fees for the use of the rail infrastructure of Fährhafen Sassnitz GmbH.

The type, amount and basis for calculating the fees are set down in the respectively effective version of the "Conditions for Using the Rail Infrastructure of Fährhafen Sassnitz GmbH".
